



Springbrook Stockhorses – Breeding Contract 2010

This contract is between the following parties:-

Dan and Anna Kennedy, trading as Springbrook Partnership (The Stallion Owner)

and

_____ (The Mare Owner).

The Mare Owner agrees to breed his/her/their mare named

_____, Registration No _____, as described on the back page, to Springbrook Riptide, ASH No. 154366 for the breeding fee of \$700 plus agistment and vet fees, payable at collection of the mare.

The following conditions apply:

1. A live foal is guaranteed (LFG). Should the resultant full term foal not stand and suckle, the Mare owner is entitled to one return privilege the following breeding season. This only applies if the Mare Owner advised the Stallion Owner within one week of the death of the foal and is accompanied with a licensed veterinarian statement. The LFG is void if, in the opinion of the Stallion Owner, the mare was neglected, in poor condition, exposed to unacceptable risk, undergoes surgery, or is returned to vigorous work.
2. The mare must be swabbed for bacterial and/or viral infections before breeding and a copy of the swab results supplied on delivery of the mare. The Mare Owner agrees the Stallion Owner may have a veterinarian check the mare for normal breeding conditions and to perform such other veterinary services as the Stallion Owner deems necessary at the Mare Owner's expense.
3. The stallion owner shall make the best effort to ensure the mare is impregnated by the stallion. If after all reasonable attempts, the mare does not become pregnant, the service fee will not be charged or it will be refunded.
4. The Stallion Owner will have a lien over the mare and foal/pregnancy until all fees are paid in full. The relevant breeding slips will not be completed until all fees are paid.
5. The Stallion Owner and its representatives shall not be held responsible for accidents to, sickness or death of the mare and/or foal. The Stallion Owner will take all reasonable precautions in the care and supervision of the Mare/s (and/or foal if applicable). The Stallion Owner does not offer insurance in any form on mares and/or foals not belonging to The Stallion Owner. Mare Owners are advised to seek and finance their own insurance.
6. Vet fees will be charged directly to the Mare Owner.

7. Agistment fees will be paid at collection of the mare. They will be as follows (incl. GST):
- § \$11 per day dry mare, \$16.50 per day wet mare (The Stallion Owner supply feed)
 - § \$5.50 per day dry mare, \$11 per day wet mare (The Mare Owner supply feed)
 - § **Free agistment for 5 days**, available if swabbed, and in season on arrival, and taken home when off season.

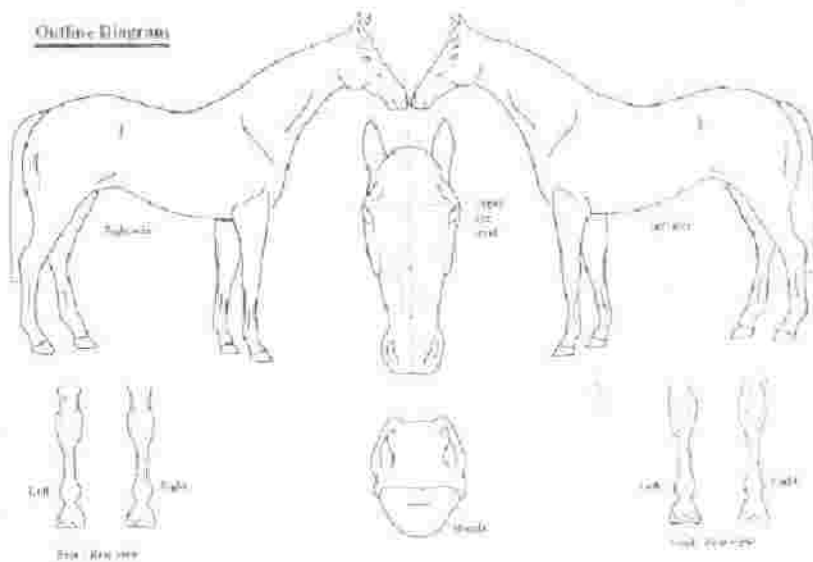
